ABOUT THE CONFERENCE

This is the second African Philanthropy Conference held under the banner of The Centre on African Philanthropy and Social Investment (CAPSI) in collaboration with the Africa Philanthropy Forum (APF), African Philanthropy Network (APN), East Africa Philanthropy Network (EAPN), Southern Africa Trust, Harvard Center for African Studies and TrustAfrica. ABOUT THE HOSTS

1. WITS CAPSI

Located at Wits Business School in Johannesburg, South Africa, The Centre on African Philanthropy and Social Investment (CAPSI) was established to bridge the gap in the study, research and practice of philanthropy and social investment in Africa.

Global interest in the field of philanthropy and social investment in Africa and continents outside of Euro-America is growing exponentially. Recent years have seen a considerable increase in research and writings related to these topics. Despite this, the study of these fields is in a nascent stage, with very little formal academic research, teaching and publications available in Africa. In response to this lack of dedicated, formal academic focus, Wits Business School and the Southern Africa Trust introduced the Centre on African Philanthropy and Social Investment.

The Centre aims to support the advancement of this field, by filling the current gaps in teaching, research, and publication. The Centre serves as a source of knowledge, a cultivator of partnerships, and a catalyst for innovation, community engagement and a heightened sense of citizenship and social responsibility throughout the African continent and beyond. From the outset, this initiative took on a wider pan African outlook – seeking to understand philanthropic behaviour in different contexts and histories.

TRUSTAFRICA

TrustAfrica seeks to strengthen African initiatives that address the most difficult challenges confronting the continent.

Our dream of a better Africa resonates with the continent's collective vision and roadmap as expressed in the African Union's Agenda 2063: the Africa We Want, and the United Nations Sustainable Development Goals.


We currently focus on three critical areas: Securing the conditions for democracy; Fostering African enterprise and achieving broadly shared prosperity, and Cultivating African resources for democracy and development.

TrustAfrica is a partner to the continent's change agents, its diverse civil society organizations, top-ranked think tanks and vibrant social movements. Our aim is to support civic engagement that achieves justice, accountability and equitable development in Africa.

Over the years, APF has established a stronger presence on the Continent, with footprints in Cameroon, Côte d'Ivoire, Egypt, Ethiopia, Ghana, Kenya, Morocco, Nigeria, Rwanda, South Africa, Tanzania and Uganda, through its regional meetings and conferences. APF has also invested in the development of two volumes of the Toolkit for African Philanthropists and the "Why Give" Series, which consist of interviews with Africa's strategic philanthropic leaders to showcase their motivations for giving.

Since its inception, APF has reached over 2,500 philanthropists, social investors and key stakeholders in the philanthropic space across Africa and the world. Through APF's high impact convening and initiatives, the organization has facilitated collaborations, amplified the work of change-makers and shared best philanthropic practices and strategies for promoting homegrown development.

5. SOUTHERN AFRICA TRUST

We are a non-profit organization that undertakes activities that contribute to the reduction of poverty and inequality. These include activities related to public policy, official poverty reduction processes, human rights, stakeholder engagement, human and economic development, research, training, and capacity building.

Our work strengthens the voice and agency of poor people in regional policy processes, to reduce poverty and inequality in Southern Africa, in ways that promote regional interconnection and a regional agenda. 6. AFRICAN PHILANTHROPY NETWORK

APN is the only continent-wide network of organizations and individuals in Africa and its diaspora who promotes the culture of philanthropic giving. APN brings an ecosystem of philanthropy support member organizations serving different forms of philanthropy currently in 48 African countries. Established in 2009, APN was conceived as a space for African institutions to interrogate and intervene in the power dynamics that shape how resource mobilization, distribution and spending impact the possibilities of transformative change in Africa.

APN focuses more explicitly towards the multi-stakeholder end of the philanthropy spectrum -emphasis on philanthropic models, philanthropy as act of participation, empathy, a chain of solidarity– African philanthropy as a development tool. Our approach is founded on intersectionality and puts gender, race and class at the heart of analysis.

7. THE EAST AFRICA PHILANTHROPY NETWORK

The East Africa Philanthropy Network (EAPN) is a voluntary membership association that brings together philanthropic organizations in the East Africa region with an aim of promoting homegrown philanthropy. The Network draws its membership from charitable Family Trusts, Community Foundations, Corporate Foundations, and other types of Grantmaking and non-grantmaking organizations interested in promoting philanthropy in the region.

EAPN's mission is to nurture a local giving and resource mobilization culture through effective grant-making, advocacy and networking. This aspect includes looking into the resource base, capacity, credibility and practices of various development actors and the extent to which the operational context supports thriving local giving and effective grant-making.

Emmanuel Akyeampong is Oppenheimer Faculty Director of the Harvard University Center for African Studies, and Ellen Gurney Professor of History and of African and African American Studies at Harvard University. He was appointed Loeb Harvard College Professor in July 2005.

Akyeampong is a Fellow of the Ghana Academy of Arts and Sciences (FGA), and a Corresponding Fellow of the Royal Historical Society (UK). He serves as the president of the African Public Broadcasting Foundation (US), a partnership of academic researchers, African broadcasters and African producers dedicated to the production of development-oriented programs for broadcast on television, radio and the Internet. He is a co-founder and director of the International Institute for the Advanced Study of Cultures, Institutions and Economic Enterprise (IIAS: www.interias.org.gh) based in Accra, Ghana. He served as chair of the Committee on African Studies at Harvard from July 2002 to June 2006.



Tsitsi Masiyiwa

Tsitsi Masiyiwa is an African philanthropist and social entrepreneur. She is Executive Chair and Co-Founder of Higherlife Foundation, whose primary goal is to invest in human capital development to build thriving individuals, communities and sustainable livelihoods.

As a result of her work and experience establishing and growing Higherlife Foundation over the last twenty-five years, Tsitsi has become an advisor and thought partner to universities, national leaders, and social entrepreneurs on issues of education, health, leadership development, and youth empowerment.

In Malawi, Mary worked as the Executive Director of the National Association of Business Women, a local NGO advancing women's economic empowerment for fourteen years. For five years, she worked as Program Director for Malawi for the United States government-funded United States African Development Foundation. She also worked as chairperson of the Civil Society Advisory Group for the United Nations Entity on Women Empowerment and Gender Equality (UN Women Malawi) from 2016 to 2020. She has served on the boards of two parastatal organizations in Malawi - The Technical, Entrepreneurial and Vocational Education Authority (TEVETA) as its Chairperson from 2013-2016 and as a Commissioner of the Competition and Fair Trading Commission (CFTC) from 2012-2015.

Jeremy Maarman is in the business of showing that communities can indeed lead their own development. This stems from an expressed belief in the human concepts expressed in Africa as Ubuntu and Ujamaa. He has over 17 years of experience in the community development sector having obtained a certification in Community Development Work from the University of the Western Cape. Jeremy worked for the government at all levels before entering the non-profit sector in 2009 where he worked for some of the most reputable organisations in the West Coast district.

Co-founding and Director of the Initiative for Community Advancement he has grown the organization from an informal national youth network into a strong and vibrant Community Foundation. Jeremy is on a mission to show in what ways rural communities always have and continue to invest strategically into causes that they care about. Grace Maingi

Grace Maingi is a human rights lawyer who has been working, over the last twenty years, in the governance not-for-profit sector in Kenya. Her work has focused on civic education and engagement, constitutionalism, promoting free and fair elections, women's rights, and growth within the legal profession in Kenya. Her passion for social justice and community development aligns with her main drive to reduce inequality. Grace Maingi was recently appointed as the Executive Director of the Kenya Community Development Foundation (KCDF). KCDF began its work in Kenya in 1997 as a public foundation that nationally supports communities to address their priority needs and challenges sustainably.



Marwa El Daly

Maadi Community Foundation

Marwa El Daly is the Founder and Chairperson of Waqfeyat al Maadi Community Foundation (WMCF), which is the first Community Foundation in Egypt and a pioneering initiative for reviving and modernizing the Waqf / traditional endowment model that used to be the backbone of civil society in Egypt and the Middle East for centuries. Marwa is also an Assistant Professor at the American University in Cairo (AUC) teaching courses related to the management of NGOs, innovation and philanthropy, as well as social entrepreneurship at the School of Global Administration and Public Policy (GAPP). Marwa El Daly is a member of the Board of Directors of the National Federation of NGOs in Egypt.



Marwa El Daly is the winner of the distinguished African Philanthropy Award in 2012 granted to her by the African Grant-makers Network in South Africa in appreciation for her work in strategizing philanthropy across Africa and internationally. She was recognized twice as a Social Entrepreneur / Innovator by Ashoka Arab World and by Synargos Institute (2006 & 2010) to become a permanent fellow for both international organizations. In addition, Marwa is the first recipient of the Rockefeller and ISTR's (International Society for Third Sector) Award as the best researcher in strategic philanthropy and the Civic Sector. This award was presented to her at the University of Barcelona in 2013. In 2014 she was recognized by the BBC 100 women to represent women of the Middle East and North Africa.

Driven by the entrepreneurial spirit of the people of Kibera, SHOFCO became the largest grassroots organization in the slum. Today, SHOFCO impacts over 2.4 million slum dwellers across 14 urban slums in Kenya. SHOFCO is on the front lines of COVID-19 response in Kenya's urban settlements, delivering health care, WASH, food relief, and economic stability at scale. In 2018, SHOFCO became the youngest-ever organization to receive the Conrad N. Hilton Humanitarian Prize, the world's largest humanitarian prize awarded to nonprofits that have made extraordinary contributions to alleviate human suffering.

A National Research Foundation A-rated scientist, Shabir A. Madhi is a Professor of Vaccinology in the School of Pathology at the University of the Witwatersrand and Director of the world-renowned Medical Research Council Vaccines and Infectious Diseases Analytics Research Unit (VIDA). Madhi is the National Research Foundation/Department of Science and Innovation SARCHI Chair in Vaccine-Preventable Diseases and he is Co-Director of African Leadership in Vaccinology Expertise (ALIVE). He chairs the National Advisory Group on Immunization in South Africa. Madhi was formerly President of the World Society of Infectious Diseases and he is the immediate past Executive Director of South Africa's National Institute of Communicable Diseases. As a trained paediatrician, Madhi's research has focused on the epidemiology and clinical development of vaccines against pneumonia and diarrhoeal disease. These studies have informed World Health Organization recommendations on the use of the lifesaving pneumococcal conjugate vaccine and rotavirus vaccine in children; and influenza vaccination of pregnant women. In 2016, Madhi received the European and Developing Countries Clinical Trial Partnership Award for Scientific Leadership and in 2013 the Medical Research Council Lifetime Award Platinum Medal, amongst other accolades. In January 2021, Madhi takes up the position of Dean of the Faculty of Health Sciences at Wits University. His qualifications include MBBCh (Wits), MMed (Wits), FCPaeds(SA), PhD.



Richard Mihigo

Immunization and Vaccine Development, WHO Africa Regional Office

Dr Mihigo is a senior public health specialist with over 25 years of experience in designing, implementing and evaluating disease control programmes at national and international levels.
